The noncore standards constitute a more ambitious target that hospitals are encouraged to work toward; current accreditation requires hospitals to reach a cumulative score of 40 percent on the non ...

Until June 30 th 2005, health facility's accreditation to NHIF has been based on its infrastructural capacity. This approach, however, did not highlight processes and quality improvement in health care delivery.
